1. Coaches are continuing to not provide N SYSA web generated rosters to the referee for games.
 - a. We have no confirmation that the individual coaching staff is RMA certified.

 - c. The referee has the authority to refuse the game to start without this roster. Don't be the coach that gets that referee.

7. Coaches continue to report the lack of referees at matches. We have been experiencing ~25% referee shortage in our matches. This is with Small Sided and Full Sided alike. I have no way of measuring those matches with three referee assignments are receiving 100% coverage.
8. No movement by Clubs to initiate efforts for the recruiting of new referees has been seen.
 - a. Referees are a diminishing resource. We all must seek to find new blood for the ranks of Kitsap Peninsula Referee Association.
 - b. KPSRA has committed providing a referee training class in the next few weeks.
 - c. Clubs are asked to support this effort.
 - i. Campus Club membership for possible candidates.
 - ii. Establish a ratio of two new referees per team.
 - iii. Emphasize the importance of having available numbers to provide to support full referee teams for all games.
 - d. Support to this belief can be verified by recent news articles on National and Local news stations featuring the shortages and the reasons for the decline.

9. We cannot have coverage if resources are not available. KPSRA is not the best resource to seek new members.
 - a. They have a diminishing association with the candidate pool.
 - i. Injuries and High school play impact the ability for referees to cover our Association matches.
 - b. Clubs are the source for new resources.
 - c. It will not become a priority until Clubs make “Referee recruitment” a priority.
10. HS League play
 - a. Most all Clubs are reporting limited to no registration in the HS age groups.
 - b. We have spoken to this dilemma several times.
 - c. I stand by my proposal of a Co-Ed league in either a 7 V 7 or 9 V 9 format.
 - d. A second alternative to this would be participation in a Spring CoEd league.
 - e. It is very important that we accept change to allow these young players and opportunity and location. Please remain open in your Clubs discussions.

- * Chris B *(SKSC): would it be feasible to combine players from other teams because I don't see entire teams being able to commit. We only have 6 teams and only 2 teams that share the same gender/age. GH thought that would be doable.
- * Vicky (TSC): possible that the soccer to the max weekend could be used for this for a U13 and above tournament.
- * Steve S: Maybe talk to KPSRA and see if it was a 9v9 30 minute half would they discount the cost to referee the games.
- * Shannon B (BSC): How would the cost be distributed if it was individual players made up from various teams. Jason says that with the cost of the turf and referees it can be reasonable that each player would pay \$5-7 a game.

 6. A WYS Referee clinic was held 10 October. A small amount of referee candidates attended and certified. A second class was held this past weekend.
 7. We cannot have coverage if resources are not available.
 - a. I have already reviewed reports of those new referees being mistreated by coaches and parents alike.
 - b. I also would like to dispel a belief that seems to be abundant in many of the Clubs.
 - Misconduct can be awarded without a card being shown.
 - Unacceptable conduct to the referee, players, or others is still misconduct.
- √ Far too many reports have been submitted detailing foul language and unacceptable conduct by **Parents and Coaches**. Do not believe that this is acceptable conduct merely because misconduct is not awarded. (i.e.... **CARDS**)
- √ SSReferees should never be subject to the kinds of treatment they have been subject to these past games.
- √ It is documented that the average new Grade 8 Referee will not award a misconduct for the first 3 - 4 years. Gaining confidence and understanding of the application of the Rule of Law. Learning and trusting in the decisions. And learning the correct application of the issue of misconduct will precede the first issue of any card.
- √ Therefore Unacceptable conduct is not necessarily followed with misconduct awarded. The simple act of misconduct warrants Administrative review.

Ranking Process

Teams are awarded Points based upon:

- 6 points for each Win
- 3 points for each Draw (Tie)
- 0 (zero) points for a loss
- 1 point for each goal scored (up to a maximum of 3 per game for both teams)
- 1 point for a shutout - holding an opponent scoreless (in the event of a 0-0 tie, both teams will be awarded 4 points)

Ties in divisional standings between two (2) teams will be resolved as follows:

- Head to Head (winner of match between 2 teams)
- Winner of most games
- Goal differential (goals scored minus goals against) with a maximum of ten goals per game
- Most goals scored with a maximum of ten per game
- Where applicable, team who participated in, and ended season with the higher Sportsmanship ranking will reign.
- If a tie still exists, divisional placement will be determined by coin toss.

US Soccer 9U,10U,11U and 12U PDI

Washington Youth Soccer has adopted the US Soccer 9U – 12U Player Development Initiatives.

Please note the 9U - 11U age group changes that include:

- No Heading. If player heads the ball regardless of the outcome (own goal, goal, preventing a goal) an in-direct free kick is given, NO Card.
- The use of the Build out Line
- GK No Punting or Drop kicking

Build-out Line Reminders:

- a. Goal-kick: the opposition can enter the “build out line” area as soon as the ball leaves the penalty box/area.
- b. GK in possession of ball with their hands. The opposition retreats back to the “build out line”, they can enter the build out area as soon as the goalkeeper puts the ball into play.
- c. If the GK puts the ball into play quickly (throw, roll or set the ball at their feet) the opposition can now defend immediately, even if they are inside the “build out line” area.

Offside:

Is in effect at the **build out line** (NOT the halfway line) for 9U - 11U

The 12U age group follows FIFA Laws.

9U-10U Rules of Competition

- **Build out lines:** a. Goal-kick, The opposition can enter the build area as soon as the ball leaves the penalty area, b. GK in possession with their hands. 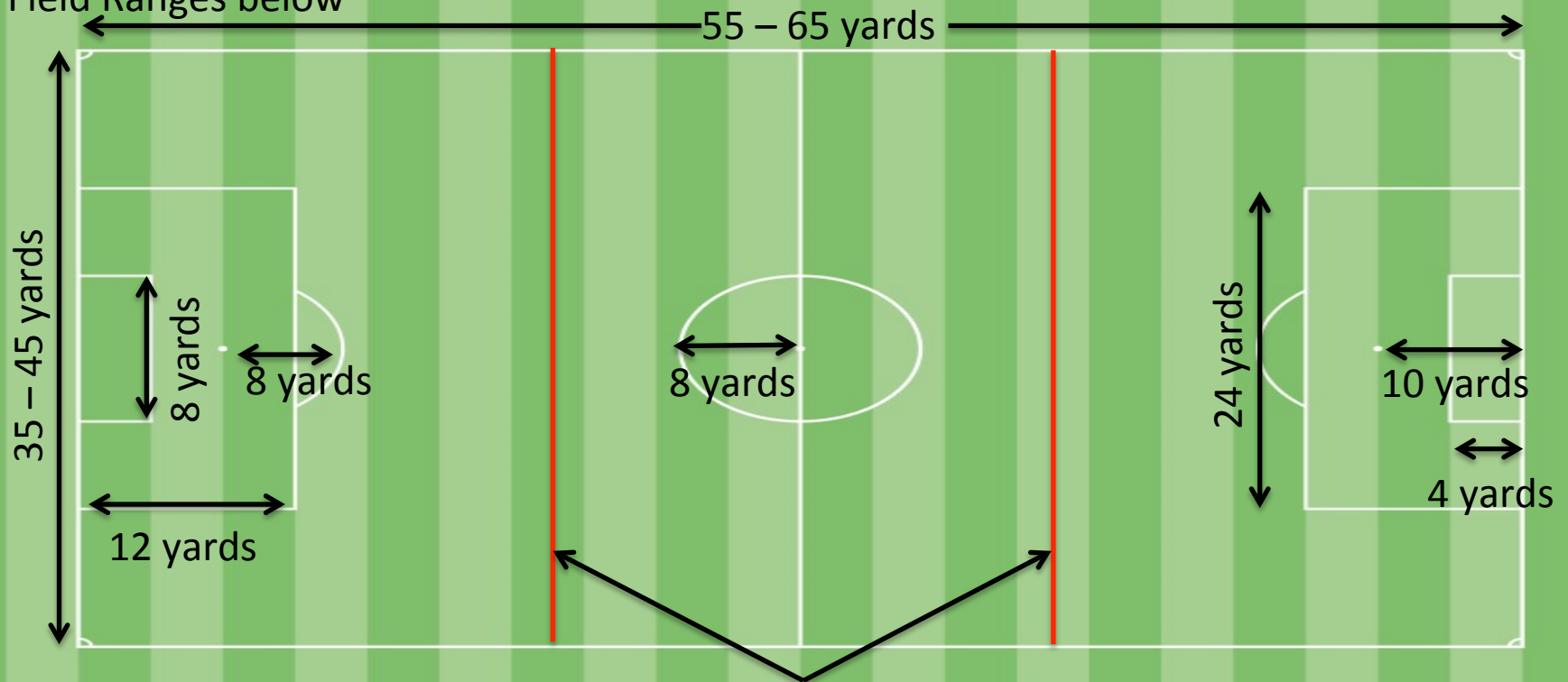

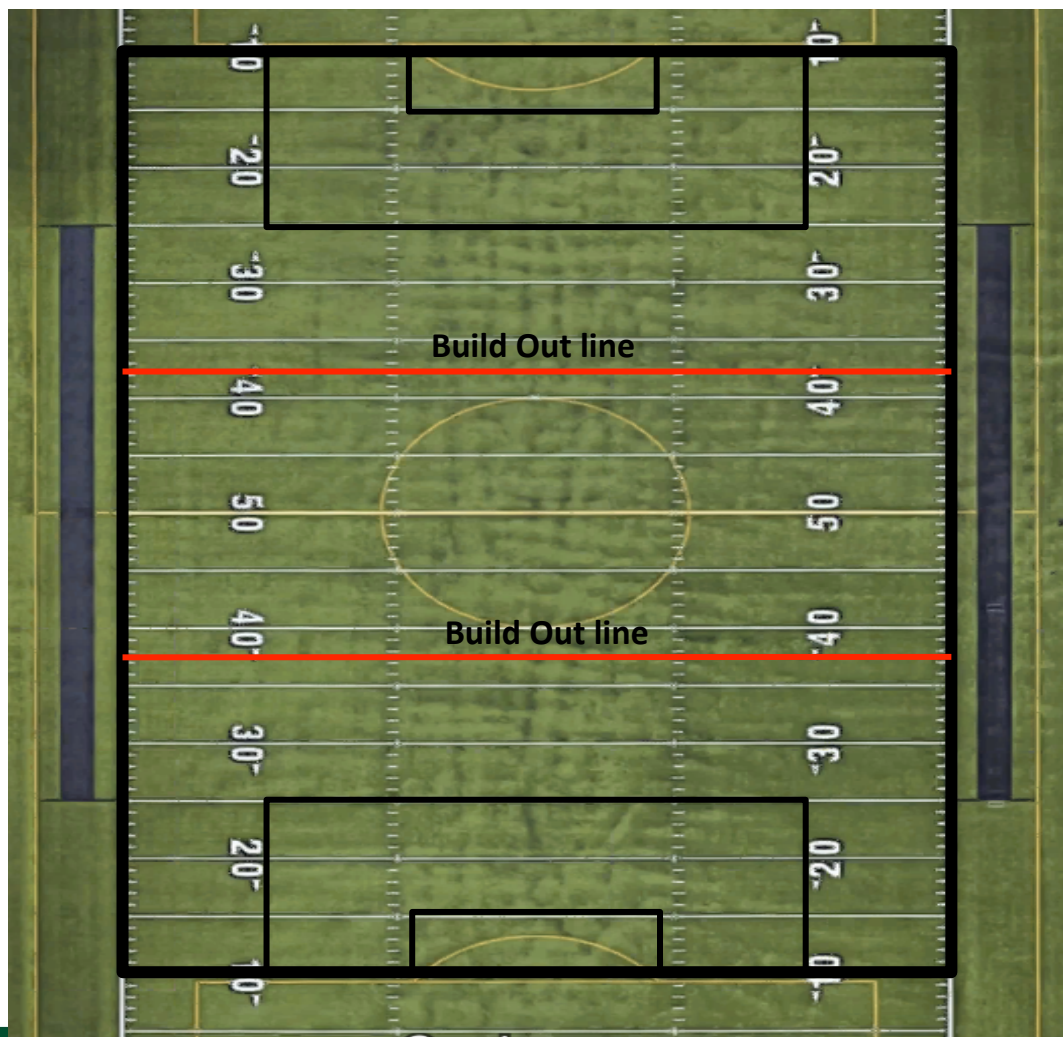

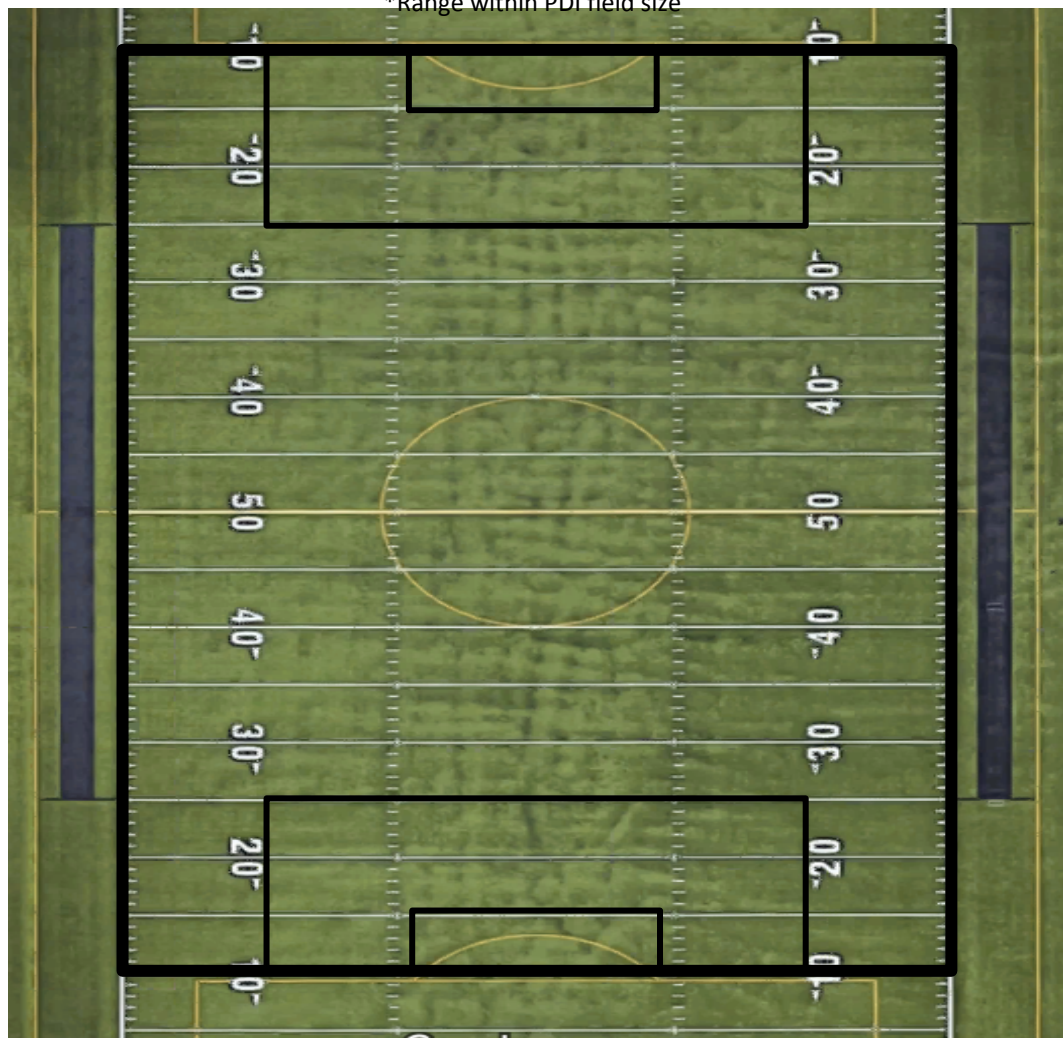
