- * KAFC putting Academy teams in NSYSA Rec league
 - * The intent is that the parents don't want to travel 80-90 minutes for games at U6, U7, and U8.
 - * Question: Would you have set rosters or a pool of players that are just assigned each week.

Answer: Going to the set roster would be more consistent.

- * KAFC states that there are certain players at certain levels that are more proficient that would probably be put on the same team for team development.
- * Comment: A kid at that age group can be very good and take away touches from the other players.
- * Question: If you were asked to play the teams up a level, would that be an issue? Would you play all the players up a level?
- * Answer: It is tough to answer this with out seeing the play first. Some of the kids should play up from the beginning. A lot of the kids have been with the club for a year or so, probably show play up.
- * Comment: Our rec league is a fixed roster league, so once the roster is set, there is no moving players week to week. Also, WYS doesn't allow paid coaches at Recreational.
- * WYS says they will have to double check on the paid coaches and if this can be possibly an exception. They will look into the By-Laws.
- * KAFC assures that the coaches are not looking for blow out wins. They have the goal that the players, from both teams, are having fun and want to continue playing.
- * NSYSA teams have not played in two years and KAFC typically trains year round.
- * Comment: Why does KAFC not start their own academy "league" instead of trying to join an existing REC association? Where is the support for the local clubs from KAFC? KAFC states that they have offered support, for example, the keeper training offers, the offer to help at summer camps, etc

 - * Comment: If a team is dominating and the season has been playing a few games, it is really tough to reschedule the brackets by moving a team up.
 - * Comment: SKSC offered to hold some scrimmages with the KAFC teams to see how the teams complete.
 - * Comment: One club states they think the KAFC teams should play true age, not be forced to play up. Only the clubs affected with teams should be the ones to vote on this issue.
 - * Comment: Not all the KAFC players are of higher level. There is the risk that is a few players from a KAFC team are missing, they may face a better team from the REC side.
 - * Comment: The KAFC players are rostered to a RCL team, so they would need to be rostered to a REC team? Can a player registered for a higher level, then register for a lower level team? Answer: the KAFC players are registered as academy recreational players.
 - * Bob and Steve state that we are not going to rebracket divisions midway through the season. It will be September to November.

Subj: August 2021 VP of Comp Report

- 1. Just seven weeks to the return of Recreation Soccer.
- 2. For the Rec players, they are returning after a long period of down time. Coaches, plan for a gradual re-entering. Save those sore muscles and injuries. Be gentle.
- 3. The schedule meeting will be virtual on 21 August. It will take a bit to be ready. We hope that Clubs will be ready to complete team assignments earlier so we can look at what will be the best way to match up teams.
- 4. Have the Clubs been reaching out and asking their facility providers what are the stipulations of use for the fields? We do not know the conditions and protocols your fields providers will be placed on the fields you use. Start early! Work with your providers to know and understand what will be required to use the fields you will be using.
 - a. New Covid masking directions from the Governors office may put some stipulations and hoops to overcome.
 - b. With schools going back with masking protocol, the fields that we use on school district property will more than likely be the conditions of use.
 - c. Will we need to separate vaccinated and non-vaccinated spectators?
- 5. How are Clubs doing in finding and training of Small-Sided Referees.
- 6. Small-sided referees will need that support as well. Clubs need to schedule classes and support training. Please post your training on the NSYSA website. "Timing is everything!"
 - a. Some may not always be available for one Club's date and time; but may be able to attend another Club's training. I have forwarded a lesson plan for this training and should allow for common understanding.
 - b. We have always required an RMA for the Small-Sided Referee. This year will more likely be the same. But the time it takes to get the job done may be an inhibitor to being a referee.



- Clubs, please take a moment to verify the Small-Sided Referee pay scale for your Club. These pay scales will be what is paid for the season.
 - 8. Statistics say, 40 60% of newly trained referees last less than one year.
 - a. What is the reason why?
 - b. Do we need to better emphasize the "Respect' initiative sponsored by WYS?
 - c. How do we teach respect to the referee and how does that benefit Referee retention?
 - The Scheduling meeting is just around the corner. Please place 21 August on the calendar.
 - a. Location is TBD. Presumably, it will be at the YMCA in Silverdale.
 - Due to no comparative statistics from the previous year, team assignments will be a best guess event.
 - Lastly, I must ask that we prepare for the field and weather. We finely get past Covid and then comes the summer.
 - a. It is predicted high heat this summer. With that we must give consideration to the Heat Index while training and playing.
 - b. Hydration is necessary!
 - c. Limit strong physical exercise during high heat times.

- 1. Just one week to the return of Recreation Soccer.
- 2. What have we left to do? Fields painted, nets in place and anchored down, the 2 yard line painted on the parents side to keep them back?
- 3. For the Rec players, they are returning after a long period of down time. Have coaches followed the plan for a gradual re-entering. Have we protected those sore muscles and injuries. Be gentle.
- 4. Todays most important word is "Adapt." There will be "CHANGE" thrown our way. Accept and adapt.
- 5. Start early! Work with one-another to know and understand what will be required to use and be at the fields you will be using.
 - a. New Covid masking directions from the Governors office are now stipulations and hoops to overcome.
 - b. With schools going back with masking protocol, the fields that we use on school district property will more than likely be the conditions of use.
 - c. Will we need to separate vaccinated and non-vaccinated spectators?
- 6. How are Clubs doing in finding and training of Small-Sided Referees.
 - a. Steve has worked hard to modify the element of eligibility for SSReferees below the age of 18. This will create a greater opportunity to recruit new young referees.
- 7. Small-sided referees will need that support. Clubs need to schedule classes and support training. Please post your training on the NSYSA website. "Timing is everything!"
 - a. Some may not always be available for one Club's date and time; but may be able to attend another Club's training. I have forwarded a lesson plan for this training and should allow for common understanding.



- 8. Statistics say, 40 60% of newly trained referees last less than one year.
 - a. What is the reason why?
 - b. Do we need to better emphasize the "Respect" initiative sponsored by WYS?
 - c. How do we teach respect for the referee and how does that benefit Referee retention?
- 9. I must ask that we prepare for the field and weather. Covid has returned with a vengeance.
 - a. Has each Club opened the file box and pulled out their Return to Play Document?
 - b. Has each Club reviewed and verified the calling tree and know who must be notified should a Covid exposure be experienced?
 - c. Has each coach been provided a WYS Return to Play document and Club RTP document?
- 10. And finely, we have indicators of serious forest fire conditions to continue for some time to come. You may remember previously we experienced many days of no practice due to air quality. Should the smoke come, we will need to implement these protocols once more.

- 11. I am implementing some actions as a result of the WYS RTP Guidelines.
 - a. Game times must be tightly controlled.
 - i. Game scheduling modules have specific times between games. In general, 30 minutes is allowed between games. The teams whose games have just ended must clear the field before the following game teams may enter the field.
 - ii. All players being substituted will enter and leave the field at the half line of the players side of the field. (This is an exception to the new FIFA Laws of the Game)
 - iii. Players on the bench and coaches will wear masks as social distancing cannot be achieved at the benches.
 - iv. Please review WYS RTP Guidelines for additional instructions for Covid precautions.
 - v. All spectators will wear masks and maintain 3ft social distances.
 - vi. Non-vaccinated spectators will wear mask and gather at the extreme ends of the stands/sidelines and maintain appropriate social distances of 6ft.
 - 12. As stated before, Time is critical for all game to be completed on time. Forcing game into the twilight will require lights. Lights are a large expense. This is money we need not spend.
 - a. Should extended delays in the restart of play due to injury or other reasons be experienced, the referee has the authority to reduce play time 5 minutes per half.
 - b. We must preserve the 30 minutes between games.



WYS Gameday Protocols and Safety Plan Fall 2021

As of 8/29/2021, the WA State Governor's Office and Department of Health are <u>NOT</u> requiring players, coaches, or spectators to wear masks at training or games, although they may chose to wear one. Physical distancing among spectators is strongly encouraged. WA Youth Soccer will continue to follow the guidance of these two offices with regards to the health and safety of players. Should any new guidelines come out that effect players, coaches, or spectators at training or games, this document will be updated and redistributed.

NOTE: Certain counties, clubs, or field providers may have tighter restrictions in place that may involve mask mandates, etc, and it is the responsibility of the hosting club to notify opponents in advance of what rules are in place.

IN CASE OF A POSITIVE COVID-19 DIAGNOSIS:

When an athlete is diagnosed with COVID-19:

- Have the player stay home and isolate for 10 days.
- If the infected player was in contact with their team within 48 hours of diagnosis (date of positive test or date of symptom onset) whichever was earlier), notify the parents/guardians that "someone" on the team has tested positive for the virus (do not reveal name of infected individual). Outdoor soccer activities are considered low risk exposures and do not require quarantine unless >15 minutes of contact with the infected individual within 6 feet over 24 hours, or other special circumstances (ie, carpool, social or indoor exposure). Each player may choose to be tested for COVID-19 (especially non-vaccinated players).
- If the infected player played in a game with their team within 48 hours of diagnosis, Club COVID Contact must notify the opposing team immediately with suggestions as above.
- Infected player cannot return to practice or games until they have written medical clearance from their physician.
- Disinfectant all equipment.

When a coach has come in contact with or is infected with COVID-19:

- Get tested and stay home.
- Contact your club immediately.
- Inform the team if you have maintained social distance from all your players, players do not necessarily need to get tested but it can be considered, as stated above.
- Disinfect all equipment.

CLUB RESPONSIBLITIES:

• By registering your team to the league, the club and their teams, coaches, players, and parents agree to follow all league protocols, policies, and responsibilities.



- Provide opponents with any rules that are specific to your fields to be shared with visiting teams.
- If possible, have separate ingress and egress points to minimize traffic flow coming into and leaving the field/complex. Send to opponents.
- Provide adequate field space for social distancing.
- All clubs are responsible for keeping attendance for which players are at every game.
- Have an effective communication plan in place, identify strategies for working with public health to notify adult leaders, youth, and their families if the organization learns a participant or adult leader has developed COVID-19 and may have been infectious to others while at a youth activity, while maintaining confidentiality as per law.
- Have an action plan in place, in case of a positive test (steps listed below in case of positive case)
- Train and educate all staff to protocols and requirements, including state and local regulations, CDC recommendations, and other necessary information.
- Clubs should forward by email to coaches, players, and parents, all league protocols, policies, and expectations around game day.
- Clubs will email their referee group about all league protocols, policies, and expectations around game day.
- Clubs will communicate any cancelations or shutdowns as quickly as possible to all team administrators and club leadership.
- Clubs will designate a COVID-19 contact person for any positive cases to communicate with opposing teams and referee assignor should a case arise around a game weekend.
- Clubs should communicate with coaches, players and parents that COVID-19 protocols will follow local public health and CDC guidelines.

COACH RESPONSIBILITIES:

- No coach that is sick or has signs or symptoms suggestive of COVID-19 should attend.
- Maintain physical distance (>6 feet) as much as possible.
- Make sure that your team has left the field within 5 minutes of the game ending.
- Clustering of players should be avoided. There should be no gathering and socializing before or after the game by players. Coaches should not assemble their teams closely together for instruction; players should be spaced at least 6 feet apart for team meetings or instruction.
- No handshakes or fist bumps during or after the game.

PLAYER RESPONSIBILITIES:

- No player that is sick or has signs or symptoms suggestive of COVID-19 should attend.
- Wait until prior game's teams have vacated the bench area before entering the space.
- <u>Soccer bags should be placed at least 6 feet apart from one another where possible</u>.
- Use hand sanitizer before and after the game.
- Clustering of players should be avoided.
- No handshakes or fist bumps during or after the game.



PARENT/GUARDIAN RESPONSIBILITIES:

- No parent/guardian/caregiver or player that is sick or has signs or symptoms suggestive of COVID-19 should attend.
- Spectators should remain socially distanced as much as possible.
- Do not loiter around field. Avoid gathering of people.

SCHEDULING:

- Schedule games with time buffers in between where possible to allow minimal contact between games.
- If the scheduled home team does not have field availability, they should work with the away team to host the match on the scheduled day.
- Should both teams not be able to make the scheduled game day work, but there is an open date acceptable to both teams that can be scheduled, teams may do so.
- No forfeiture fees for last minute cancellations due to COVID-19 may be assessed to an opponent.

CLUB PLAYER PASS:

- Player pass may be used in the event of injuries/ sickness to provide enough players to field a team up to (14) players for 11v11, (12) players for 9v9, and (10) players for 7v7 matches.
- Teams may only use up to 3 player passes for any game.
- All player passes must be monitored and recorded by the club for contact tracing purposes.

REFEREE RESPONSIBILITIES:

- Before leaving for the field, Referees should ask themselves the following questions:
 - Have you knowingly come into contact with anyone who has, is being tested for, or is exhibiting signs of coronavirus?
 - Are you exhibiting any of the following symptoms which are not caused by any other condition?
 - Fever or chills
 - Shortness of breath
 - Difficulty breathing
 - Fatigue
 - Muscle or body aches
 - Headache
 - New loss of taste or smell
 - Sore throat
 - Congestion or runny nose
 - Nausea or vomiting



Diarrhea

• If the referee answers yes to any of these questions, they should notify their assignor and refrain from officiating the game.

Pre-Game:

- The referee crew should set up their belongings in an area away from all others while maintaining 6-ft/2-yd space from each other.
- Assistant referees are expected to bring their own flags to the field. The flags don't need to match each other.
- <u>Referee equipment should not be shared</u>, but if shared, it should be sanitized before and after the match.
- Referees should carry hand sanitizer and disinfectant wipes for their own personal use.
- Referees may use a regular whistle or an <u>electronic</u> whistle.
- During the referee crew pregame discussion, continue to maintain 6-ft/2-yd space and insure all COVID-19 protocols are discussed.
- Player Check-In:
 - Rosters
 - If possible, try to receive the roster or match report electronically ahead of time.
 - If not, have the coach place the roster at the end of the bench to minimize close contact.
 - If the leagues has roster with pictures printed on them, then no need for player cards (exception may be a player pass). If not, have the coach read the player passes.
- Coin Toss:
 - No coin toss.
 - While maintaining 6-ft space, the Home team picks direction to attack. Away team gets kick-off.
- No player walkouts or handshakes prior to the game.

After the Game:

• For contact tracing purposes, if a referee is to test positive for COVID after a match, they need to notify the assignor immediately. The assignor will be responsible for notifying the appropriate club official.

Resulting in 26 brackets (After a single team folded, requiring in two brackets being combined and rescheduled into one)

1,270 games are CURRENTLY scheduled for 2021 Fall seasons across, SmSide, Rec and Comp areas, with PLENTY more COMP, Soccer To The Maxx and Rec Cup games still to be scheduled.

Thanks to the vast majority of the NSYSA Club Registrars and Schedulers, (more brand new than seasoned veteran), for working together and working tirelessly to get these teams formed, games bracketed and scheduled. **Well done!**

Issue for consideration: Teams are assessed by NSYSA for failing to show for scheduled matches. Clubs are fined for missing calendared NSYSA Board meetings without an excuse.

The whole Fall Scheduling campaign relies on three time-sensitive major milestones being met.

- 1) Inputting and marking Team as Ready To Schedule, enables our only hope of building NSYSA representative brackets.
- 2) Reviewing draft brackets and resulting schedules, necessary for "Good to Go" OK to all Schedulers to begin scheduling.
- 3) Returning at a minimum their first 3-4 weeks of scheduled home games essential for the successful season kick-off of coaches, families, and referee assignment opportunities.

NSYSA should consider sanctions against Clubs who fail to meet any, or all, of these Scheduling milestones. Sustainability of the whole NSYSA Fall Scheduling timeline is placed at risk when even a single Club fails to meet established milestones.

Article II. Definitions

- **4.** Emotional Misconduct improper conduct; wrong behavior. pertaining to or involving emotion or the emotions.
- 5. Physical Misconduct improper conduct; wrong behavior. of or relating to the body.
- 6. Sexual Misconduct, Including Child improper conduct; wrong behavior. of, relating to, or for sex of a person between birth and puberty or full growth.

Enrollment: 255 Players and 27 teams (largest since I have been involved with the club)

We are looking into Board Liability Insurance but the quotes seem pretty high so far at around \$2500 per year at \$300k. What are other clubs paying and anyone have a good agency they recommend? Shoot me an email vp@bremertonsc.org

Also for insurance we need a policy and procedure around safe sports and contact with minors, does anyone have a model policy we can steal and modify?

It might be a good idea for NSYSA to have official model policies for Concussions, Sportsmanship (outside the guidance Bob sent out), safety of minors, and so forth. I didn't see anything under documents on the website. Then clubs can adopt them as they want, unless we want a blanket policies as an association that all clubs fall under.

We haven't been able to resolve our issues with Chase Bank so we are exploring closing our account and opening a new one with a new Bank or local Credit Union

We are having challenges in scheduling fields for Full-Sided (9v9 and 11v11). We have historically been at Bremerton Memorial Stadium but there is competition from Warren Ave. Peewees and the high school has now decided their homecoming dance will be on the field September 18th (it's all been last minute notice). We are looking into other fields and will update the schedule as we know more. It should affect too many dates.

Director of Coaching Brian held a referee training and coaches training this past weekend so we are hoping for a full complement of refs.

We are in full preparations for Soccer to the Maxx on October 3rd and have shared it will all of our eligible teams with an expectation that they participate. When we meet as a board we will discuss if we can cover some of all of the fees for our teams.

There's a registration system issue that I'm not sure how we fix it. If a player has ever registered with another club (including camps and clinics) then registers for fall soccer with a different club their registration doesn't transfer from Sports Connect to Affinity and no notification is provided until you realize the player isn't showing up on your State Roster. There should be some notification to someone about this so it can be resolved as it occurs.

We have found a new treasurer, and she has completed her RMA, but due to our account issues she can't be added to our bank account. Also, we need to figure out how to submit a new 990 form to the IRS and change all the people associated with our account since none of them are still involved with the club.
