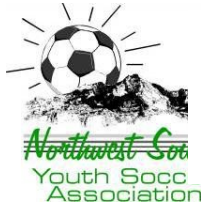

1. Soccer to the Max 2018.
 - a. Louie Bond will be chairman to take up the cause.
 - b. North Kitsap Soccer Club and Bremerton Soccer Club have stepped up to host STTM games. Thank you Clubs.
 - c. Soccer to the Maxx registration has been set at \$115 for all teams and all ages.
 - d. The date, 07 October, was approved for the tournament.
 - e. 14 September is the STTM registration deadline. It is earlier. Clubs please communicate with your teams and make them aware.
 - f. Attached is the flyer for this tournament.

2. Recreation Cup 2018.
 - a. Through much discussion we have failed to come upon an agreeable date for this tournament.
 - b. Quarter Finals will be played at Gordon Field.
 - c. Rec Cup registration is \$300 per team.
 - d. Registration deadline is 10 October.
 - e. Round Robin play will begin October 20 and complete the weekend of 11 November.
 - f. Many Clubs are reporting that they are experiencing low HS age teams forming. We may have no representation at this age.
 - g. I have been asked if a HS team goes to the SSUL league for Fall play, may they play in Rec Cup in District IV.
 - i. I find this reasonable and will allow pending review with WYS.
 - h. Draft flyer attached

3. Recreation play.
 - a. Changes to the NSYSA Operating Procedure are necessary prior to the August Scheduling meeting.

- b. Clubs begin play 01 August. No updated Operating Procedure has been submitted for review.
 - i. The Board must decide with this August meeting how this delay shall be applied.
 - ii. Coaches need to train their players. To do so, they also must know.
- c. President Darcy has posted some proposed changes. Please read and be ready to speak to these changes.
 - i. Without a vote and approval at this August Board meeting we are creating discord to clubs planning and coaches training.
4. Safe Sports Initiative.
 - a. I recently forwarded information regarding the implementation of a program to ensure the security and safety of players.
 - b. I will recommend to the Board a committee to be formed to develop policy and procedures for implementation of this initiative.
 - c. Clubs are asked to review their use of individuals without RMA Certification.
 - d. Rule of Thumb:
 - i. If an adult will be to limit one-on-one interaction.
 - ii. Ensure all individuals involved in Practice, travel, lodging, etc., are paired with a second adult.
 - iii. All must have RMA certification
5. Scheduling meeting will be held 18 August. Location TBD.
6. Clubs are asked to acknowledge and implement the WYS Respect campaign. This campaign is recommended to be reviewed at the start of the season meetings.

7. Positive Coaching Alliance
 - a. Two classes have been scheduled for PAC to be presented in Kitsap County.
 - b. Each class has the capacity for 75 students.
 - c. To Date, with 12 remaining to the scheduled date, there are (7) seven registered attendees.
 - i. Unless convinced other, I will cancel the class if numbers do not improve by 03 August . We cannot ask instructors to travel two hour R/T for so few participants.

8. This item is critical to our soccer season. I see no movement by Clubs to initiate efforts for the recruiting of new referees.
 - a. Referees are a diminishing resource. We all must seek to find new blood for the ranks of Kitsap Peninsula Referee Association.
 - b. KPSRA has committed to five (5) training classes to bolster the number of available referee pool to officiate.
 - c. Clubs are asked to support this effort.
 - i. Campus Club membership for possible candidates.
 - ii. Establish a ratio of two new referees per team.
 - iii. Emphasize the importance of having available numbers to provide to support full referee teams for all games.
 - d. Support to this belief can be verified by recent news articles on National and Local news stations featuring the shortages and the reasons for the decline.
 - e. Websites supporting this phenomena are:

9. We cannot have coverage if resources are not available. KPSRA is not the best resource to seek new members.
 - a. They have a diminishing association with the candidate pool.
 - b. Clubs are the source for new resources.
 - c. It will not become a priority until Clubs make “Referee recruitment” a priority.
10. HS League play
 - a. Most all Clubs are reporting limited to no registration in the HS age groups.
 - b. We have spoken to this dilemma several times.
 - c. I stand by my proposal of a Co-Ed league in either a 7 V 7 or 9 V 9 format.
 - d. A second alternative to this would be participation in the SSUL league.
 - e. It is very important that we accept change to allow these young players and opportunity and location. Please remain open in your Clubs decisions.

- 6) Table 1 Page 1 U11 and U12 penalty mark change from 8yds to 10yds.
- 7) Page 2 Article 2 Section A 1 change the letter O to number 0.
- 8) Page 12 Article 8 Section D change from Scheduling Fees to Game Fees.
 - 1) Change Scheduling to Game.
 - a. Remove Fall
 - i. Change \$36.00 to \$9.00 per home game.
 - ii. Change \$100.00 to \$16.00 per home game.
 - iii. Change \$175.00 to \$18.00 per home game.
 - b. Remove as written.
 - c. Remove as written.

Add a new b. State Cup Tournaments \$30.00 per home game.

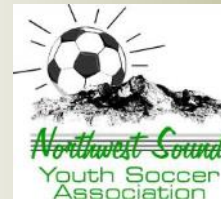

Address: 1199 Union Ave W., Bremerton, WA 98312** info@olympicsportscenter.com **Tel: 360-479-8388**. We ask that every Club complete the following in preparation for a successful Fall season!

Pre-Scheduling meeting requirements:

1. Club VP of Competition/Scheduler review 2017 Fall NSYSA Recreational Soccer season results.
 - a. Identify team strengths and weaknesses for appropriate placement in brackets and divisions.
 - b. Review all teams that played up an age bracket. Determine placement for 2018.

2. Club Registrar reviews all administrative requirements. (Reference NSYSA Registrar's [notebook](#)
 - a. Reference [Birth Year Player Age matrix](#) to determine authorized team levels
 - b. Identify teams returning with similar rosters from previous year.
 - c. **Advance each team's age one year from previous year!**
 - d. Identify new teams.
 - e. Teams with seven or more players from the previous year retain WYS Team ID #.
 - f. New teams or teams with less than seven returning players shall obtain new team WYS Team ID #.
 - g. Clubs shall identify U11-U18 teams which desire to participate in the Competitive Bracket for play utilizing the Competitive Play [Application](#) (path: **Registrar > Applications > Competitive Play**).

Note: Please use the following nomenclature for naming teams:

3. Club VP of Comp identify all known critical dates which may impact schedule (i.e. desire for no Sunday play, School AP / SAT Testing, School Dances, Recreation Cup, Soccer to the Max, field conflicts, etc.) Save these dates:
 - a. **Soccer to the Max – DATE Sunday October 7, 2018**
 - b. **Recreational Cup - DATE proposal REC CUP - 4th week of season Round Robin. Also looking at 10/21, 28, 11/4 for Round Robin play. NSYSA must complete Round Robin play by November 18, 2018.**

Coaching conflicts:

4. Requested scheduling considerations must be noted in managed Teams "Comment" area **prior** to marking Teams as "Ready to Schedule".
 - a. Club Registrar will have annotated "Comments" in the NSYSA manager Teams section requesting scheduling considerations **prior** to August 15 2018.

- b. When coaches have multiple teams, Club Registrar will have annotated “Comments” in the NSYSA manager Teams section for each team requesting scheduling considerations **prior** to August 18 2018.
5. Note: Requests for **“No Sunday Games” cannot be assured.**
 - a. Examples of expected Comments include:
 - i. AM / PM requests. (e.g. “AM games; also coaching team 440263993” or “Prefer home games on Sunday’s if necessary”)
 - ii. Multiple team commitment, (Coaches with multiple teams must identify Assistant Coach and/or substitute team staff to reduce scheduling unavailability) Annotated for each team.
 - iii. Work Schedule conflicts.
 - iv. Local school: dances, known field conflicts, etc.
 - v. Known SAT Testing Dates: **October 6, 2018, November 3, 2018 and December 1, 2018**
 - vi. Known ACT Testing Dates: **October 27, 2018, December 8, 2018**
6. Teams traveling greater than one hour will not expect to have away matches scheduled earlier than 10:00 AM and can expect that distant away matches will be completed by 6:00 PM
7. Club VP of comp has assigned assistant coach and additional team staff will support coaches having conflicts.

Scheduling Requirements:

1. Team rosters correctly assigned with balanced numbers on all teams.
2. Teams registered must have a Coach assigned.
 - a. Those teams without coaches must have a club representative registered to each team to be scheduled. (This may affect multiple teams until coaches are assigned)
3. **Club Registrar shall have updated each team on the NSYSA web site as “Ready to be Scheduled” not later than end of business August 14 2018 in preparation of the scheduling meeting.**
4. Teams playing in other leagues must be identified to ensure placeholders in the scheduling process.
5. Club Schedulers have downloaded current NSYSA [“Schedulers Tool Kit”](#) reviewed both Instructions and your Club’s inventory of fields for correct and complete understanding.

NSYSA Waiver Information:

1. Clubs shall have previously submitted Washington State Youth Soccer Medical Play down Waivers for review to the NSYSA Board for consideration and approval. [Forms and procedure on-line.](#)
2. Clubs shall have previously submitted requests for roster modification to the NSYSA Board for consideration and approval.

Tournament Play Schedule Consideration Requests:

1. Clubs shall present a completed 2018 version of [Wenatchee Cup Team Identifier form](#) at the Schedule meeting for teams requesting exemption to attend this tournament. Dates October 12-14, 2018 for **Wenatchee Apple Cup.**
 - a. Failure to identify teams will result in denial for exemption from NSYSA Fall Soccer Season schedule commitments.
 - b. This understanding is clarified within the NSYSA Operating Procedures; Article 8, Section B.4.
 - c. League matches will be scheduled with greater priority over tournament matches.

- d. Attempts will be made to pair teams with other teams participating in tournament play for those exceptions approved by NSYSA.
- e. Reasonable requests for reschedule of games impacted by tournament play will be honored. It will be the responsibility of the team participating in the tournament to facilitate the reschedule. This reschedule will not impact other scheduled League play and may be played on an alternate date and time.
- f. Reschedules shall be completed within four weeks of play or current schedule date. Variances from this requirement will result in fines being assessed.
- g. No team may participate in any tournament not sanctioned by NSYSA, WYSA, or US Youth Soccer which will impact League play.

Referee Payment U11 & Above – Full Sided Game:

1. Reference current [NORTHWEST SOUND YOUTH SOCCER ASSOCIATION & KITSAP PENINSULA SOCCER REFEREES ASSOCIATION AGREEMENT OF UNDERSTANDING](#) for current Fee Schedule, Billing and Payment procedures.

Referee Payment U10 & Below – Small Sided Game:

1. For those Clubs participating in the NSYSA 2018 Fall Soccer U10 & Below League season, Clubs will verify payment schedules in advance. NSYSA will be handling referee payments.
2. NSYSA will generate a report for each two week period of games and will forward to the NSYSA Treasurer.
 - a. NSYSA Treasurer will pay the referees and apply a charge to individual Clubs for the cost.

League Scheduling Fees:

1. Payment is not required at time of the NSYSA Schedule meeting.
2. Clubs will be provided an invoice following the Scheduling Meeting
3. Payment is due thirty days after billing date.

Recreation Cup:

1. Each Club shall be prepared to offer to host specific ages and brackets of the NSYSA Recreation Cup.
2. Tournament format will be completed **Before November 18, 2018.**
3. Semifinals and finals will be played after November 18, 2018. Specific game dates are TDB
4. Clubs shall provide the Recreation Cup Director Club Points of Contact (POC). Name, address, and phone numbers shall be provided prior to the sixth week of League play.
5. Player participation will be accepted for teams of each playing year solely. Teams with older players desiring to play at lower age brackets must remove the older players by the roster freeze date.
