Registrar:

- * Held Registrar meeting on 3/16 and was well attended.
- * Sent out registrar packet to registrars to help with new registrars and standardize procedures.
- * Louie mentioned that the SOC has been having discussions about kick around and having the state insurance cover it as a sanctioned event.

Treasurer:

- * Passed the budget at the 2015 AGm
- * Account cleared up to 3/31
- * Still have about 10 uncashed referee checks. Please contact your referee coordinator now to contact the referees to encourage them to cash the checks.
- * Player fees still outstanding for KAFC and NKSC. Received partial payment from KAFC. Discrepancy with what KAFC had for registered players, vs what NSYSA Paid the state in player fees.

- * Val is getting questions about various "secret meetings". Even if there is a club "executive board meeting", there needs to be minutes from it and posted so there is a Record of what happened and any decisions were made.
- * Operating procedures
 - * Darcy says that the current operating procedures are not consistent with the Proposed disciplinary document. Determined that the disciplinary procedure would be changed to reflect the approved cost of 75.00 vs 100.00 for a protest fee.
 - * Steve Vonheeder states that Section 5, article 13 and 14 would need to be changed or removed and the disciplinary document referenced in the Operating Procedures. Louie would propose to remove section 5, article 13 and 14 and use the disciplinary committee document as it is written as a guideline until it is finalized. The disciplinary committee doesn't follow section 5 article 13 and 14, so having it included doesn't make sense.
 - The disciplinary document will be added to the Operating Procedures and sent to the clubs for review. Voting to approve the Operating Procedures will occur at the May meeting.
- * Tryouts for HS ages have been going on. Players that have not made the RCL club are being displaced and they need a place to go. Clubs need to submit their club Select tryout dates to Steve Shively.

 - * SKSC (continued)
 - * Discussion about having a fine accessed if a game is rescheduled within a certain time frame or a certain number of times it is rescheduled.
 - * KPSRA states in the agreement that all changes 14 days prior to the scheduled game date / time, the scheduler posts to the site. Less than 14 days the scheduler need to contact the administrator.
 - Less than 24 hours prior to the scheduled game time / date results in a full crew fine.
 - * Determined that if a game is reschedule within 72 hours of the scheduled date / time or a game is rescheduled 3 or more times, which includes a time change for the same date, NSYSA will fine the club a \$25.00 fee.

* NMYSC

- * Registration opened April 3rd.
- * Approximately 25 kids signed up so far over the weekend.
- * Planning to do a soccer camp July 13-17th approximate cost is \$35 and it will run from 9:00-12:00 each day.
- * Plan is to have one of the turf fields up and running by September.

* NKSC

There is currently no tryout policy in place. Bob says that the clubs should get together and figure out what they want to make the working relationship better.
